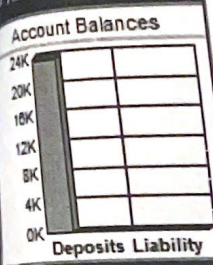

Unit 214 board members met August 22, 2018 at the Sigler Senior Center to discuss the annual Hattiesburg Sectional Tournament to be held February 22 - 24, 2019. Present were Sandra Baggett, Bob Kirkpatrick, Linda Valentine, Pat Millette, Cathy Gersh, and Ava Herring.

Cathy Gersh, co-chairman of the upcoming event, passed out a spreadsheet detailing expenses and income from previous tournaments for the years 2013 - 2018. Also presented was a listing of attendance by session for the years. Based on her analysis, she said that attendance and the price per session were the primary factors in determining profit and loss.

There was discussion of player fees charged at tournaments by other clubs. Most exceeded our charges.

Linda Valentine moved that fees at our next tournament be \$13 per regular session for ACBL members and \$17 for non-members. Fees for Swiss teams would be \$120. The motion passed by acclamation.

Cathy also submitted a schedule of Tournament Committees and their chairpersons and a list of recommendations for the 2019 Tournament. In addition to the increased price for play, local members are to be encouraged to attend and Partnership Chair is to help organize additional Swiss teams.

President Sandra Baggett adjourned the meeting.
