The minutes of the 36th AGM were read, approved and signed.

Presidents Report. TH submitted his report in which he reported a good year for the club, tinged with sadness at the loss of Jill Robson and Tom Morgan. The new alerting system had been adopted well by the club. International laws of bridge have been revised (78 pages!) broadly in line with the SBU. He passed on his congratulations to winners both within and out with the club.

Treasurers Report. J Mole reported a loss of £211 for running costs for the club. The congress made a profit of £308.06. A donation of £150 was made to the Mayoress's Charity: Chemo for Berwick. She recommended that table money be increased to £2.00 whilst reducing the annual subscription to £1 plus SBU levy. She reported that we have 66 full playing members at present.

Competition secretary's report. D Drysdale made her report (copy on file) and recommended that Pearson Pot should be held after Christmas, with Calder Martin starting earlier and spread out over the year. This would mean that new, less experienced members of the club would not be faced immediately with Match Pointed scoring. Committee to consider this when making up program.

Team captains reports. K Mole reported that the Bears had enjoyed their season and finished 5th in their league. R Drysdale reported that the A Team had finished 6^{th and} would therefore remain in league 1. He outlined his plans for ensuring the team remain in the top league; G Sandwith requested that the 2 teams play their matches in Haddington on separate evenings. COMPETITION SECRETARY'S REPORT 15TH MAY 2008

I have very much enjoyed being competition secretary very much. I managed to persuade seven other members to direct a competition, and this has spread the load considerably. I feel that this was a positive move, involving more people in the running of the club, and my thanks go to them all.

One of my aims has been to speed up play, and I think this has been achieved, with very few evenings finishing after 10.30, and many finishing earlier than this. To those who felt that they were rushed, my apologies, but with practice, I am sure that you will learn to play faster, which will keep everybody happy.

I said that I enjoyed my year, but I do have one complaint – the travellers. I don't think I scored a single competition without mistakes, and I frequently had to phone people early on Wednesday and Friday mornings, often getting them out of bed, to sort out the situation. PLEASE, be careful entering the scores – always ask E/W to check.

I have only one recommendation to make for next year, and that is that the Pearson Pot should be held after Christmas, and the Calder & Martin start earlier and be spread through the year. There are two reasons for this – I believe that a few of Jean's class members are hoping to join the club, and I don't think it appropriate that they be immediately faced with a match pointed competition – aggregate is more suitable for beginners. Also, in September, members are sometimes still on holiday, or still busy tidying their gardens, and miss the first few weeks. As the Pearson Pot only has seven rounds, they find that they have not played enough to have a chance of winning. The Calder & Martin competitions, on the other hand, have a longer run. I would ask the committee to consider this when they make up the programme.
