SOME THINGS THAT HAPPENED AT THE UNIT MEETING THAT WOULD BE OF INTEREST TO THE BOARD.

THE UNIT HELD ITS ELECTION OF OFFICERS FOR THE 2010 ELECTION AND THE FOLLOWING PEOPLE WERE ELECTED:

DICK MYERS------PRESIDENT ANN HEDDEN-----VICE PRESIDENT NICHOLAS HAMMOND----SECRETARY NANCY MOTES-----TREASURER PATTY TUCKER GAVE A REPORT TO THE UNIT ON ATLANTA JUNIOR BRIDGE AND THE UNIT AWARDED AJB \$2000 TO HELP THEM DEFRAY THEIR EXPENSES.

DICK ALSO MENTIONED THAT A COMMITTEE HAS BEEN SET UP TO HELP EXPLORE WAYS OF FUNDING FUTURE YOUTH BRIDGE. SOME OF OUR MEMBERS ARE ON THIS COMMITTEE. ANY CONTRIBUTIONS GIVEN TO THIS COMMITTEE ARE TAX DEDUCTIBLE.

#### POLICIES & PROCEDURES:

THE FINAL DRAFT ON THIS WILL BE FORTHCOMING. HOWEVER, SOME CHANGES WERE MADE REGARDING THE OPERATION OF THE DBAA GAME.

AN APPOINTED COMMITTEE WILL PLAN FOR AND OVERSEE THE WEDNESDAY NIGHT GAME UNDER GENERAL GUIDELINES ESTABLISHED BY THE DBAA BOARD OF DIRECTORS.

THE FEE WILL BE \$8.00 PER PLAYER. THE DBAA CLUB GAME IS TO BE SELF-SUSTAINING, OVER THE LONG RUN.

THERE IS TO BE A NON-PLAYING DIRECTOR. ONLY IN EXTREME CIRCUMSTANCES SHALL THE DIRECTOR PLAY IN A CLUB GAME.

THE FOOD COORDINATOR WILL RECEIVE A FREE PLAY. IF THE DIRECTOR PLAYS HE MAY RECEIVE A FREE PLAY FOR HIMSELF.

THE \$30 LIMIT ON REFRESHMENTS WAS ELIMINATED AND THE AMOUNT TO BE SPENT IS LEFT UP TO THE DISCRETION OF THE DIRECTOR. STANDARD STRATIFICATION FOR THE OPEN GAME WILL BE: FLIGHT A—OPEN, FLIGHT B – 1500-2500, FLIGHT C –0 TO 1500. THE DIRECTOR MAY USE HIS OWN DISCRETION ON MODIFICATION TO OPTIMALLY STRATIFY THE GAME.
